Medical Illness Policy: If we believe that your pet has become ill or injured, we will try to contact you at the numbers provided. If this occurs, doctors and staff at Casper Animal Medical Center (CAMC) are authorized to provide treatment to my animals. In emergency circumstances, and if you or your alternate contacts cannot be reached, doctors and staff at Casper Animal Medical Center are authorized to provide emergency care as needed on a continuous basis until I can be reached.

Evaluations for Dog Daycare I understand that my dog(s) must be evaluated before joining in any play groups and that any dog who shows aggression towards humans or other dogs will not be allowed to participate in the daycare play activities. I understand that if my dog is boarding and shows any signs of aggression, my dog may not be allowed to participate in the play groups, and, if my dog is coming for the sole purpose of daycare, my dog may be removed from the play groups. The evaluation is done by Sunrise Pet Lodge employees, and it is their sole discretion that determines a dog's suitability for the daycare environment.

Assumption of Risk I understand that if my dog participates in daycare, that it is a play group activity and there are some risks inherent in this activity. Despite the best supervision, scratches, bites and other more serious injuries may occur. I knowingly assume all risks and incidental risks. My decision to have my dog participate in these activities is voluntary. I also understand there are potential risks of injury to my dog in the daycare environment.

Daycare Structure Dogs participating in daycare at Sunrise Pet Lodge are placed into play groups based on size, energy level and temperament. We do not mix dogs under 20 pounds with the large dog group, or dogs over 30 pounds with the small dog group. Dogs between 20 and 30 pounds are placed with play groups according to their temperament and energy level. Dogs who are participating in daycare are supervised by Sunrise employees at all times. All dogs are given a two hour nap from 11am to 1pm. Daycare is available Monday—Friday 7:30am to 6:00pm. We request that you make reservations in advance for daycare to ensure that we are adequately staffed. If we are full, we will not be able to take walk in daycare appointments.

Waiver and Release of Liability

In consideration of use of Sunrise Pet Lodge's facilities and receipt of its services, the undersigned "I" or "me" agree to the following terms and conditions relating to my use of services provided by Sunrise Pet Lodge.

Agreement. This document "Agreement" is intended to be a binding agreement between Sunrise Pet Lodge and me.

Fees I understand that to make a reservation I must have a valid credit card on file with Sunrise Pet Lodge and that payment is expected at the time of drop off. The boarding rates are accrued on a per-night basis. If my pet is picked up after 12:00pm (noon) there will be an additional half-day charge for that day. I also understand that if I do not pick up my dog on the specified date, I shall be charged additional fees at regular rates, which may be adjusted from time to time at Sunrise Pet Lodge's discretion. If I cannot drop off or pick up my pet within the normal operating hours at Sunrise Pet Lodge, I will be subject to an additional fee of \$40. I understand that I am not entitled to a refund if I pick up my pet early, however, the amount may be credited to my account for future use. All account credits are good for one year from the date they are made.

Cancellation Policy I understand that all boarding reservations must be cancelled 48 hours before the reservation is scheduled to begin. A "no show" reservation will be charged to the credit card on file for the full amount of the reservation. Please note: this policy does not apply to holiday boarding. Please see holiday boarding policy below.

Holiday Boarding Policy Boarding reservations that encompass a major holiday (Thanksgiving, Christmas, New Year's, the Fourth of July and Natrona County School District's spring break) are charged a minimum amount equal to a four day stay. A non-refundable deposit equal to the cost of the boarding stay is due at the time the reservation is made. **If a reservation is no longer needed, it must be cancelled 10 days prior to the reserved arrival time in order receive credit on the account equal to the amount of the deposit. Cancellations made less than 10 days in advance are NOT entitled to a refund or a credit.** I understand the holiday cancellation policies and agree to the conditions under which I am and am not entitled to a credit for my deposit. I understand that I will not be refunded for any portion of my deposit should I cancel my reservation.

Medical Treatment If my pet becomes ill while under the care of Sunrise Pet Lodge, I authorize Casper Animal Medical Center to provide veterinary services that I have authorized as well as emergency care if they are unable to reach me or my alternate contacts. I understand that I must pay all costs related to the treatment of my pet.

Photo Release I, hereby grant Sunrise Pet Lodge the irrevocable and unrestricted right to use and publish photographs or other images of me/my pet, or in which I/my pet/my family may be included, in any print, electronic, digital or other media; and to alter the same without restriction. I further acknowledge that my participation is voluntary and I will not receive financial compensation of any type associated with the taking or publication of these images. I irrevocably assign such images' rights and uses to Casper Animal Medical Center into perpetuity. I hereby release Sunrise Pet Lodge and its legal representatives and assigns from all claims and liabilities relating to said images.

Vaccination Policy I understand and agree to abide by the vaccination policy set forth at Sunrise Pet Lodge. I will provide accurate vaccination records of vaccinations which have been done by a veterinarian upon request by Sunrise Pet Lodge. I understand that even though my dog is vaccinated, my dog can still contract kennel cough or other illnesses and I shall not hold Sunrise Pet Lodge responsible for such an occurrence.

Parasites We recommend that your dog is on heartworm and flea and tick medication, particularly through the summer months. Although ticks and fleas are not prevalent in Wyoming, they do live here, and can also be brought here when pets travel to other areas. For the safety of the other animals here, if your pet is found to have a parasitic infestation, treatment will be initiated and you will be responsible for all charges accrued for that treatment. You will be asked that either you or your emergency contact pick up the pet **immediately**.

Assumption of Risk I understand that if my dog participates in daycare, that it is a play group activity and there are some risks inherent in this activity. Despite the best supervision, scratches, bites and other more serious injuries may occur. I knowingly assume all risks and incidental risks. My decision to have my dog participate in these activities is voluntary. I also understand there are potential risks of injury to my dog in the daycare environment. If my dog has been known to climb or jump a six foot fence, I have alerted Sunrise Pet Lodge. If my pet should escape, Sunrise Pet Lodge is not liable for any bodily damage, death or damage to personal property. I furthermore understand that Sunrise Pet Lodge will not be liable for any illness, injury, death and/or escape of my pet provided that reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from or as a result of my pet boarding or attending daycare at Sunrise Pet Lodge.

Abandonment I understand that my pet may be considered abandoned if I have not picked up my pet from Sunrise Pet Lodge within 7 days of the scheduled pick-up date. Sunrise Pet Lodge is authorized to dispose of my pet as best deemed, including euthanasia (putting to sleep), and I am still financially responsible for all charges accrued.

Right to Refuse Service Sunrise Pet Lodge reserves the right to refuse any pet presented for daycare or lodging for any reason, or no reason, at Sunrise Pet Lodge's discretion. Sunrise Pet Lodge's employees shall determine, using their discretion, whether the behavior or condition of the pet could endanger the health or safety of the employees or the other pets at Sunrise Pet Lodge. I have fully disclosed the health and behavior of my pet and will update Sunrise Pet Lodge of any changes in my pet's health or behavior continually when I drop off my pet for boarding or daycare. The information I have provided elsewhere on this form is true and complete.

Reimbursement of Costs I shall reimburse Sunrise Pet Lodge immediately upon request for any costs or expenses incurred related to the condition or behavior of my pet. I release Sunrise Pet Lodge and any of its employees for any and all liability for any costs or damages incurred in the defense of personal injury or other claims, brought on by a third-party relating to me or my pet while visiting Sunrise Pet Lodge.
